



## **AQUANA END USER LICENSE AGREEMENT**

PLEASE READ CAREFULLY THE TERMS AND CONDITIONS OF THIS END USER LICENSE AGREEMENT ("**EULA**") BEFORE DOWNLOADING, INSTALLING OR USING EITHER OR BOTH THE MOBILE OR WEB BROWSER-BASED SOFTWARE APPLICATIONS, INCLUDING ALL RELATED DOCUMENTATION (INDIVIDUALLY AND COLLECTIVELY, THE "**App**") PROVIDED BY AQUANA LLC ("**Aquana**").

THIS IS A LEGAL AGREEMENT BETWEEN AQUANA AND YOU. THE AQUANA MASTER TERMS OF SERVICE, AQUANA PRODUCT WARRANTIES, AND THE AQUANA PRIVACY POLICY ARE INCORPORATED HEREIN BY THIS REFERENCE (which are available at <a href="https://www.aquana.com/legal">www.aquana.com/legal</a>). THIS EULA, THE AQUANA MASTER TERMS OF SERVICE, AND THE AQUANA PRIVACY POLICY (COLLECTIVELY THE "Terms") GOVERN YOUR ACCESS TO AND USE OF THE APP. ANY TERMS NOT DEFINED IN THIS EULA SHALL BE GIVEN THE SAME MEANING AS STATED IN THE MASTER TERMS OF SERVICE.

BY DOWNLOADING, INSTALLING OR USING THE APP YOU ACKNOWLEDGE AND AGREE THAT (a) YOU HAVE READ AND UNDERSTAND THE TERMS, (b) YOU REPRESENT THAT YOU ARE OF LEGAL AGE TO ENTER INTO A BINDING AGREEMENT; AND (c) YOU ACCEPT THE TERMS AND AGREE TO BE BOUND BY THEM. **IF YOU DO NOT AGREE TO BE BOUND BY THE TERMS YOU MAY NOT DOWNLOAD, INSTALL OR USE THE APP**.

- 1. MODIFICATION OF THE TERMS. Aquana reserves the right to modify and/or change any of the terms and conditions of the Terms at any time and without prior notice. If Aquana materially modifies the Terms it will make reasonable efforts to notify you of the change. For example, we may send a message to your email address, if we have one on file, or generate a pop-up or similar notification when you access the App or the Service for the first time after such material changes are made. By using the App after Aquana has posted a modification of the Terms, you agree to be bound by the modified Terms. If the modified Terms are not acceptable to you, your only recourse is to discontinue the use of and uninstall the App. The Terms will also govern any software upgrades and/or updates provided by Aquana that upgrade and/or supplement the App, unless such upgrades and/or updates are accompanied by a separate license, in which case the terms of that separate license will apply.
- 2. UPDATES. Aquana may from time to time in its sole discretion develop and provide App updates, which may include upgrades, bug fixes, patches, other error corrections, and/or new features (collectively, including related documentation, "**Updates**"). Updates may also modify or delete in their entirety certain features and functionality. You agree that Aquana has no obligation to provide any Updates or to continue to provide or enable any





particular features or functionality. Based on your device settings, when your device is connected to the internet either (a) the Application will automatically download and install all available Updates; or (b) you may receive notice of or be prompted to download and install available Updates. You shall promptly download and install all Updates, and you hereby acknowledge and agree that the App or portions thereof may not properly operate should you fail to do so. You further agree that all Updates will be deemed part of the App and be subject to the Terms.

- 3. LIMITED LICENSE. Conditioned upon your compliance with the terms and conditions of the Terms, Aquana hereby grants to you a limited, revocable, non-exclusive, personal, non-sublicensable, non-transferable, non-assignable license to install and use the executable form of the App solely for your personal use on a device (whether mobile device or other) owned or controlled by you. Aquana reserves all rights not expressly granted to you in this EULA.
- 4. SETTINGS AND UNINSTALL PROCEDURES. As part of the installation process of the App, you may be changing your computer and/or mobile device settings. By installing the App, you agree you have approved such changes. Such changes may include, without limitation, granting Aquana access to location-based information. To uninstall the App, you may use the standard uninstall procedures offered by your device's operating system.
- 5. USE RESTRICTIONS. You may not use the App in any manner that could: (i) damage, disable, overburden, or impair the App (or any server or networks connected to the App); or (ii) interfere with any third party's use and/or enjoyment of the App (or any server or networks connected to the App). Except as expressly specified in this EULA, you may not: (a) copy, modify, translate, adapt, or otherwise create derivative works or improvements, whether or not patentable, of the App; (b) transfer, sublicense, lease, lend, rent, publish, or otherwise distribute the App, or any features or functionality of the App, to any third party, including by making the App available on a network where it is capable of being accessed by more than one device at any time; (c) use the App in any unlawful manner, for any unlawful purpose, or in any manner inconsistent with the Terms; (d) remove, delete, alter, or obscure any trademarks or any copyright, trademark, patent, or other intellectual property or proprietary rights notices from the App; or (e) remove, disable, circumvent, or otherwise create or implement any workaround to any copy protection, rights management, or security features in or protecting the App. You acknowledge and agree that portions of the App, including, without limitation, the source code and the specific design and structure of individual modules or programs, constitute or contain trade secrets of Aquana and its licensors. Accordingly, you agree not to disassemble, decompile or otherwise reverse engineer any components of the App provided in object code or any other Aquana products or services, in whole or in part, or permit or authorize

a third party to do so, except to the extent such activities are expressly permitted by law notwithstanding this prohibition.

- 6. GEOGRAPHIC RESTRICTIONS. The App and Services are based in the state of Vermont in the United States. If you access the App and Services from outside the United States, you are responsible for compliance with local laws.
- 7. OPEN SOURCE. Any Open Source Software that may be accompanying the App is provided to you under the terms of the open source license agreement, the copyright notice, or the open source licenses file accompanying such Open Source Software. As used herein "Open Source Software" means open source software components provided with the App that are licensed to you under the terms of the applicable license agreements included with such open source software components or other materials for the App. THIS EULA DOES NOT APPLY TO ANY OPEN SOURCE SOFTWARE ACCOMPANYING THE APP AND AQUANA HEREBY DISCLAIMS, AND YOU HEREBY WAIVE. ANY AND ALL LIABILITY TO YOU OR ANY THIRD PARTY RELATED THERETO.
- 8. THIRD-PARTY MATERIALS. The App may display, include, or make available third-party content (including data, information, applications, and other products, services, and/or materials) or provide links to third-party websites or services, including through thirdparty advertising ("Third-Party Materials"). You acknowledge and agree that Aquana is not responsible for Third-Party Materials, including their accuracy, completeness, timeliness, validity, copyright compliance, legality, decency, quality, or any other aspect thereof. Aquana does not assume and will not have any liability or responsibility to you or any other person or entity for any Third-Party Materials. Third-Party Materials and links thereto are provided solely as a convenience to you, and you access and use them entirely at your own risk and subject to such third parties' terms and conditions.
- 9. RESERVATION OF RIGHTS. The software, content, visual interfaces, interactive features, information, graphics, design, compilation, computer code and all other elements of the App to include, but not limited to, all related documentation (the "Aquana Materials"), are protected by copyright, trade dress, patent, and trademark laws of the United States and other jurisdictions, international conventions, and all other relevant intellectual property and proprietary rights, and applicable laws. All Aquana Materials, including intellectual property rights therein and thereto, are the property of Aquana or its subsidiaries or affiliated companies and/or third-party licensors. Aquana reserves all rights not expressly granted in this EULA. You do not acquire any right, title or interest in or to the Aquana Materials, whether by implication, estoppel, or otherwise, except for the limited rights set forth in this EULA.





- 10. COLLECTION AND USE OF YOUR INFORMATION. You acknowledge that when you download, install, or use the App, Aquana may use automatic means (including, for example, cookies and web beacons) to collect information about your devices and about your use of the App. You also may be required to provide certain information about yourself as a condition to downloading, installing, or using the App or certain of its features or functionality. All information we collect through or in connection with the App is subject to the Aquana Privacy Policy. By downloading, installing, using, and providing information to or through the App, you consent to all actions taken by us with respect to your information in compliance with the Aquana Privacy Policy.
- 11. THIRD PARTY FEES. You acknowledge that third party terms and fees may apply to the use and operation of your mobile device in connection with your use of the App, such as your carrier's terms of service, and fees for phone service, data access, or messaging capabilities, and that you are solely responsible for compliance with such terms and the payment of all such fees.
- 12. TERM AND TERMINATION. This EULA will remain in effect until terminated. The EULA, and your rights and licenses hereunder, will terminate immediately upon your breach of the Terms. You may terminate the EULA by uninstalling and discontinuing your use of the App. Aguana may terminate support of the App and/or this EULA, or limit or terminate your access to the App at any time for any or no reason. Sections entitled Reservation of Rights, Collection and Use of Your Information, Term and Termination, Warranty Disclaimer, Liability Waiver and Limitation, Indemnification, and Miscellaneous shall survive any termination of this EULA.
- 13. WARRANTY DISCLAIMER. THE APP IS PROVIDED ON AN "AS IS" BASIS, WITHOUT WARRANTY OF ANY KIND. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, AQUANA HEREBY DISCLAIMS, AND YOU HEREBY WAIVE, ALL WARRANTIES, EXPRESS, IMPLIED, STATUTORY OR OTHERWISE, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE, MERCHANTABILITY, TITLE, QUALITY, AND NONINFRINGEMENT. AQUANA EXPRESSLY DISCLAIMS ANY WARRANTIES OF ANY KIND WITH RESPECT TO THE ACCURACY, VALIDITY, OR COMPLETENESS OF ANY INFORMATION OR FEATURES AVAILABLE THROUGH THE SERVICE, OR THE QUALITY OR CONSISTENCY OF THE SERVICE.
- 14. LIABILITY WAIVER AND LIMITATION. TO THE FULLEST EXTENT PERMITTED BY LAW, UNDER NO CIRCUMSTANCES WILL AQUANA, ITS OFFICERS, DIRECTORS, EMPLOYEES, AGENTS OR LICENSORS BE LIABLE TO YOU OR ANYONE ELSE FOR ANY LOSS OR INJURY OR ANY DIRECT, INDIRECT, SPECIAL OR OTHER CONSEQUENTIAL DAMAGES ARISING OUT OF OR IN CONNECTION WITH YOUR ACCESS OR USE OF, OR INABILITY TO ACCESS OR USE THE SERVICE AND ANY INFORMATION AVAILABLE THEREON. IN NO EVENT WILL AQUANA'S TOTAL CUMULATIVE LIABILITY ARISING FROM OR RELATED TO YOUR USE OF





THE SERVICE EXCEED FIVE DOLLARS (\$5). THE WAIVERS, RELEASES, LIMITATIONS ON LIABILITY AND ON REMEDIES EXPRESSED IN THIS EULA SHALL APPLY EVEN (a) IF AQUANA HAS BEEN ADVISED OF THE POSSIBILITY OR MAGNITUDE OF POTENTIAL OR ACTUAL DAMAGES, (b) IF THE PROVIDED REMEDIES FAIL OF THEIR ESSENTIAL PURPOSE, OR (c) IN THE EVENT OF THE DEFAULT, NEGLIGENCE, BREACH OF CONTRACT, BREACH OF WARRANTY, STRICT LIABILITY, OR OTHER ACTS OR OMISSIONS OF AQUANA, AND ALL SHALL EXTEND TO AQUANA'S DIRECTORS, OFFICERS, REPRESENTATIVES, AGENTS, AND EMPLOYEES.

- 15. INDEMNIFICATION, YOU AGREE THAT YOU WILL BE RESPONSIBLE FOR YOUR USE OF THE APP, AND YOU AGREE TO DEFEND, INDEMNIFY, AND HOLD HARMLESS AQUANA AND ITS OFFICERS, DIRECTORS, MANAGERS, EMPLOYEES, CONSULTANTS, AFFILIATES, SUBSIDIARIES, REPRESENTATIVES AND AGENTS (COLLECTIVELY, THE "AQUANA ENTITIES") FROM AND AGAINST ANY AND ALL LOSSES (DEFINED BELOW), ARISING OUT OF OR IN ANY WAY CONNECTED WITH (I) YOUR USE OF, OR ALLEGED USE OF, THE APP AT ANY TIME; OR (II) YOUR VIOLATION OF THIS EULA, INCLUDING, WITHOUT LIMITATION, ANY REPRESENTATION, WARRANTY, OR AGREEMENTS CONTAINED OR REFERENCED HEREIN, OR ANY APPLICABLE LAW OR REGULATION. "LOSSES" MEANS ALL DAMAGES, AWARDS, JUDGMENTS, ASSESSMENTS, FINES, SANCTIONS, PENALTIES, CHARGES, COSTS, EXPENSES, PAYMENTS, ALL COSTS AND EXPENSES OF INVESTIGATING ANY CLAIM, ALL REASONABLE ACTUAL OUTSIDE ATTORNEYS' FEES INCURRED IN CONNECTION THEREWITH, WHETHER OR NOT SUCH CLAIM IS ULTIMATELY DEFEATED AND ALL AMOUNTS PAID INCIDENT TO ANY COMPROMISE OR SETTLEMENT OF ANY SUCH CLAIM. LAWSUIT OR ARBITRATION.
- 16. DOCUMENTS. You are encouraged to download and keep a copy of this document, the Aguana Master Terms of Service, and the Aguana Privacy Policy. Additionally, Aguana will send one or all such documents to you upon your email request sent to support@aguana.com.
- 17. MISCELLANEOUS. (a) This EULA and all the policies referenced herein constitute the entire agreement between Aquana and you concerning the subject matter hereof, and it may only be modified by a written amendment signed by an authorized executive of Aquana, (b) The section titles in this EULA are provided solely for convenience and have no legal or contractual significance, (c) This EULA shall be governed by and interpreted under the laws of the State of Vermont regardless of your country of origin or where you access the Services, and without regard to its conflicts of laws provisions or the United Nations Convention for the International Sale of Goods. All actions relating to this EULA and the App shall be brought in a state or federal court located in Vermont, (d) The failure of either party to enforce any rights granted hereunder or to take action against the other party in the event of any breach hereunder shall not be deemed a waiver by that party as to subsequent enforcement of rights or subsequent actions in the event of future





breaches, (e) If for any reason a court of competent jurisdiction finds any provision of his EULA or portion thereof, to be unlawful, void or unenforceable, that provision of this EULA shall be enforced to the maximum extent permissible so as to affect the intent of the parties, and the remainder of this EULA shall continue in full force and effect, and (f) You may not assign your rights under this EULA to any party without Aquana's written consent.
